## Parent School Survey 2017-18 Results

Baltimore City Public Schools has implemented a school survey for students, parents, and staff as a measure of school climate since the 2004-05 school year. The Office of Achievement and Accountability (OAA) has administered the survey to capture stakeholders' perceptions of their schools' environment, relationships, teaching and learning practices, and school safety. The student and staff versions were not administered due to plans for MSDE to administer a statewide survey for these stakeholders. MSDE's implementation was unexpectedly delayed until 2018-19, so no climate data for students or staff were collected in 2017-18.

The parent survey has 27 questions that score responses across nine dimensions: safety, creativity and the arts, learning climate, physical environment, school resources, the administration, family involvement, overall satisfaction, and grit. Each question is answered on a 1 (strongly disagree) to 4 (strongly agree) scale, and the percentage of 3 (agree) or 4 (strongly agree) responses are calculated to determine the percent agreement with survey items at the school and district level.
